**Cleaning and care:** New and used gloves should be checked thoroughly for damage before use and after cleaning in particular. Dirt on the gloves should initially be either brushed or wiped away; the glove should then be washed with mild soap suds, rinsed in clean water and dried by air only. In case of critical contamination of the gloves, contact with the skin should be avoided. The appraisal with the above performance levels is based on tests completed on unused gloves. The transfer of the results to gloves subsequent to care treatment requires the completion of appropriate tests.



**Packaging and storage:** The gloves are connected with a bag, header card and/or yarn and have one consumer information tag for each pair or dozen. The work gloves are bundled together and packaged in corrugated cartons. The additional packaging is suitable for storage and transport.

**General information:** Particular care is required when working with turning components (risk of catching and pulling). This user information is designed to provide assistance with your choice of protective equipment, whereby the laboratory tests offer assistance with your choice but are not able to assess the actual working conditions. The user, and not the manufacturer, is responsible for ascertaining the suitability of a specific glove for the planned area of use. Protection limited to part of the hand: Glove only offers protection to palm of hand.
